## Community Engagement

There have been multiple community engagement opportunities during the 2020-2021 school year to gather and streamline feedback to inform the development the Local Control Accountability Plan (LCAP). The feedback from the LCAP was used in the development of the ESSER III expenditure plan. The community engagement opportunities included parents/guardians, school & district administrators including program administrators (similar to principals), staff from all divisions and departments, and students including homeless, those in foster care, and in juvenile hall. TCSOS did not have any identified EL students. However, students with disabilities were consulted regarding the proposed expenditures in the LCAP and the ESSER III plan.

Additionally, there were several opportunities this year to provide specific feedback for the ESSER III plan, including surveys administered to all staff and parents/guardians, students were consulted in all programs, and information was presented in an early October Board meeting where over 150 people were in attendance.

TCSOS also sought input from individuals or agencies representing the interests of Tribal Youth, Homeless and Foster Youth, youth who are low-income, youth who are incarcerated, students with disabilities, students of color, and students who are English Learners. Input was also received from community organizations and partners such as the Yes Partnership and ATCAA, the Amador-Tuolumne Community Action Agency. This outreach occurred during the time period of September 8-September 17, 2021. A survey for written responses was created and distributed during a meeting of the Student Attendance Review Board Members, which represent a number of agencies working with youth in the community, and with follow up emails as well as direct outreach to other community agencies and representatives through email and phone calls.

During our outreach efforts, we did not receive input from representatives of Civil Rights Organizations or Migratory Students. TCSOS evaluated its stakeholder engagement opportunities and determined that Civil Rights Groups/ Migratory Students are neither present nor served by TCSOS.

A description of how the development of the plan was influenced by community input.

The development of the plan was influenced by input received from students, families, school personnel, community organizations and representatives of student groups identified above. This feedback from the community engagement strategies described above was incorporated into the development of the specific strategies for addressing the loss of instructional time and providing supplemental instruction and support to identified students. Additional feedback from the LCAP remained consistent with current feedback, including a commitment to in-person learning, smaller class sizes and personalized instruction, maintain strong mental health support programs, student interventions, and enrichment opportunities. The services and opportunities for students as described in the ESSER III plan incorporate this feedback and continues to build on the LCAP goals of supporting safe and continuous in-person learning and addressing the academic, social, emotional, and mental health needs of all students. Specifically, we are providing support with increased access to student & staff COVID testing, health services expansion, providing additional staffing in instructional programs to reduce class sizes and increase intervention services, and increasing access to SEL supports.

# ESSER III Expenditure Plan Instructions

## Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
  - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

  - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

  - Implementing evidence-based activities to meet the comprehensive needs of students,
  - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
  - Tracking student attendance and improving student engagement in distance education;

- School facility repairs and improvements to enable operation of schools to reduce risks of virus transmission and exposure to environmental health hazards, and to support student health needs;
- Inspection, testing, maintenance, repair, replacement, and upgrade projects to improve the indoor air quality in school facilities, including mechanical and nonmechanical heating, ventilation, and air conditioning systems, filtering, purification and other air cleaning, fans, control systems, and window and door replacement;
- Developing strategies and implementing public health protocols including, to the greatest extent practicable, policies in line with guidance from the Centers for Disease Control and Prevention (CDC) for the reopening and operation of school facilities to effectively maintain the health and safety of students, educators, and other staff;
- Other activities that are necessary to maintain the operation of and continuity of services in LEAs and continuing to employ existing staff of the LEA.
