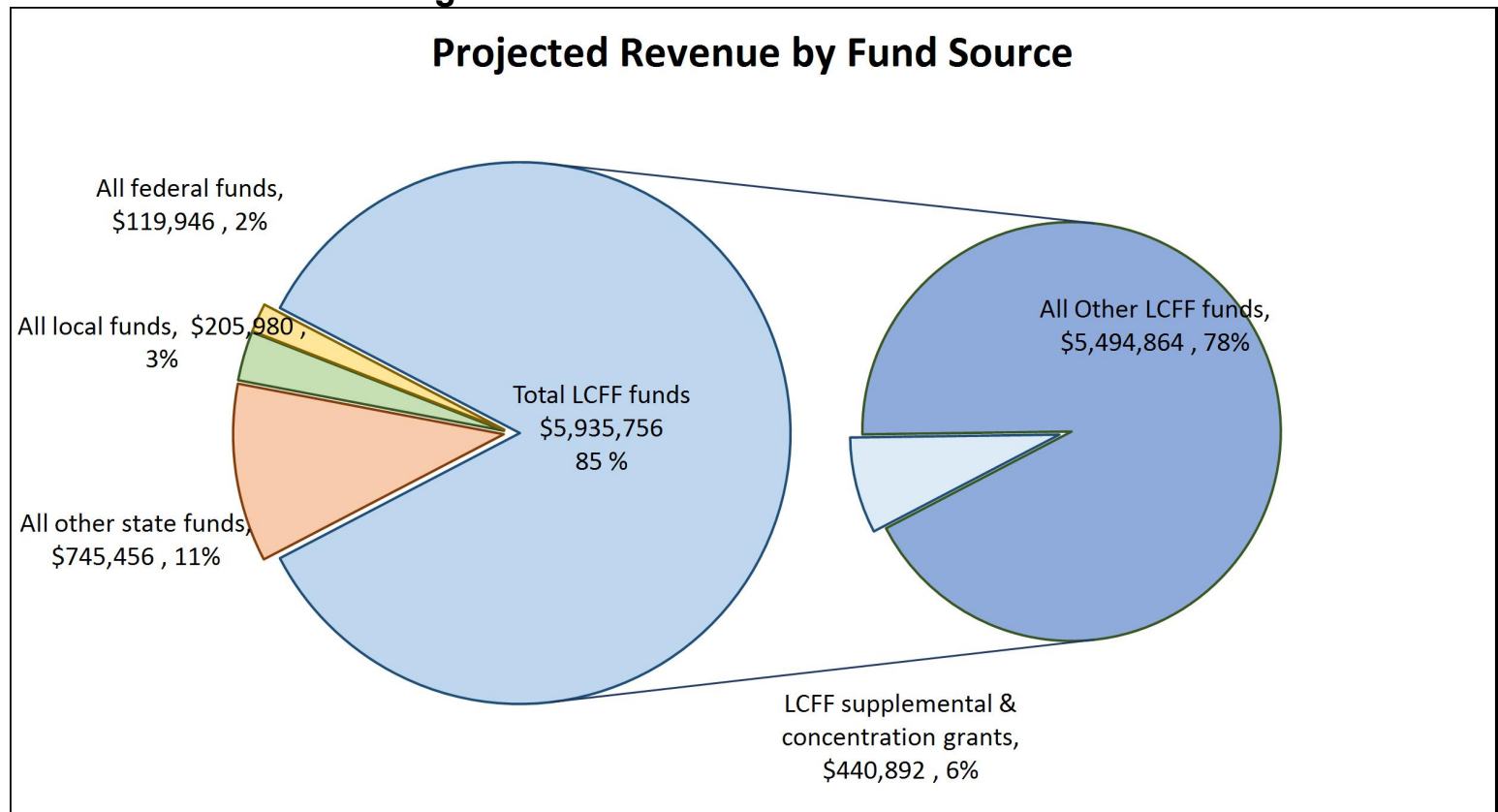

Budget Overview for the 2025-26 School Year

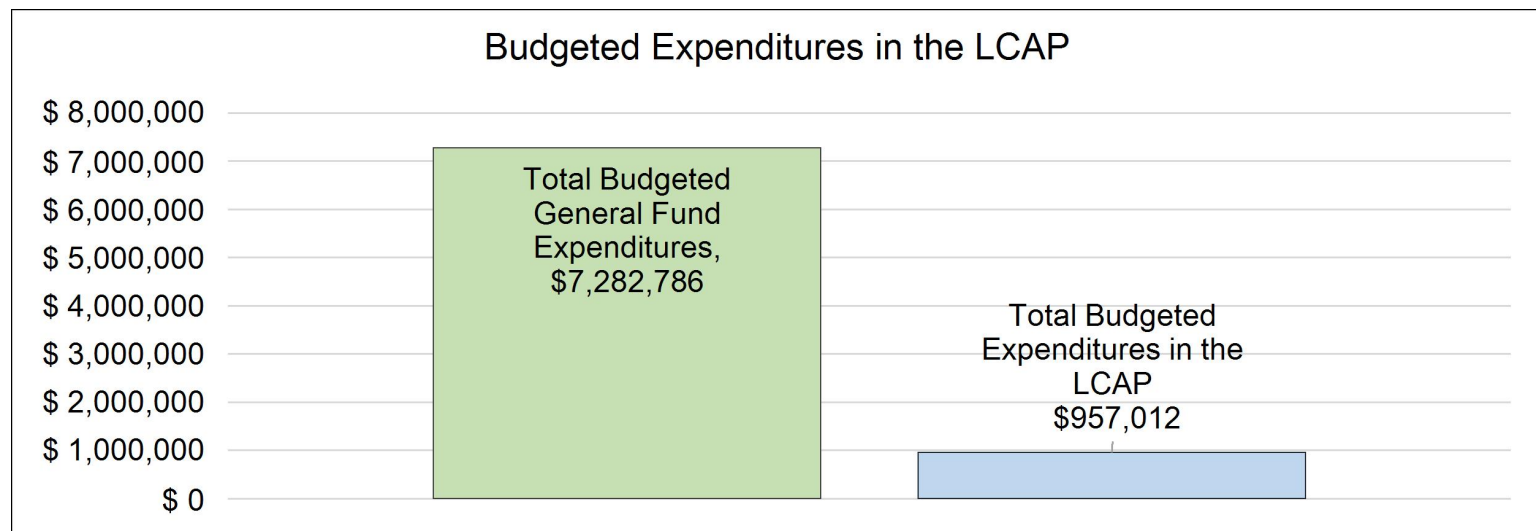


This chart shows the total general purpose revenue Soulsbyville Elementary expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Soulsbyville Elementary is \$7,007,137.33, of which \$5,935,756.00 is Local Control Funding Formula (LCFF), \$745,455.75 is other state funds, \$205,980.00 is local funds, and \$119,945.58 is federal funds. Of the \$5,935,756.00 in LCFF Funds, \$440,892.00 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

The text description of the above chart is as follows: Soulsbyville Elementary plans to spend \$7,282,785.63 for the 2025-26 school year. Of that amount, \$957,011.86 is tied to actions/services in the LCAP and \$6,325,773.77 is not included in the LCAP. The budgeted expenditures that are not included in the LCAP will be used for the following:

General fund expenditures not included in the 2025-2026 LCAP are general operating costs such as maintenance, utilities and contracted services. All other salaries and benefits, excluding Classified Paraprofessionals, include Certificated Teachers, Management, Administration, and Substitutes. Finally, contributions to other funds are not included in the LCAP.

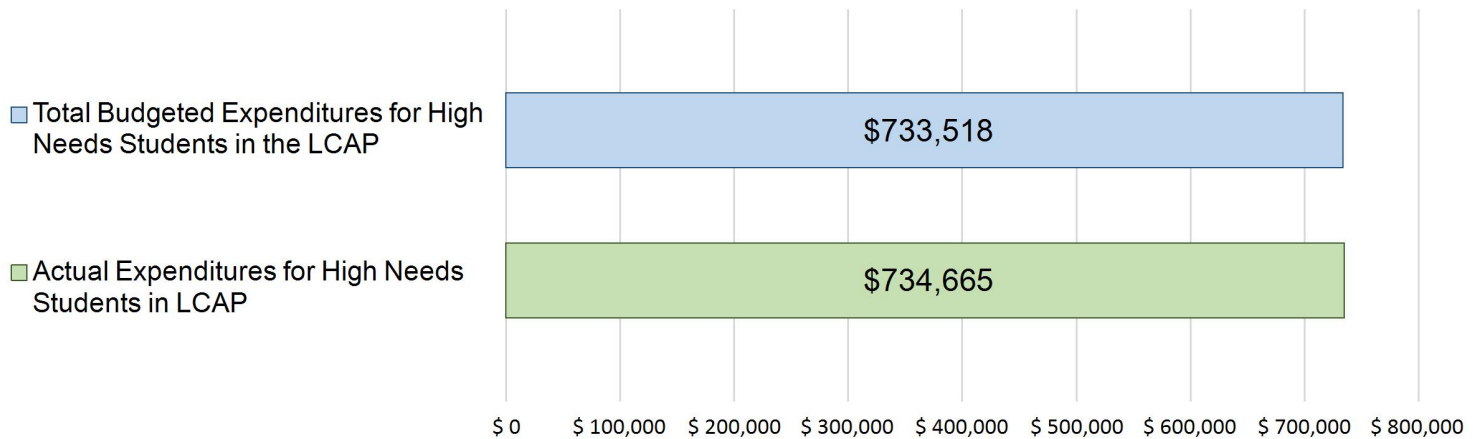
Increased or Improved Services for High Needs Students in the LCAP for the 2025-26 School Year

Plan Summary [2025-26]

General Information

Soulsbyville School is a TK-8 single school district with approximately 498 students, 68 staff members, (33 certificated personnel, including regular and special education teachers, administrators, counselor, a music instructor, highly qualified paraprofessionals) and about 340 families. The demographic makeup up the student population based on 2024-2025 is- .6% American Indian, .2% Filipino, 15.26% Hispanic, and 76.91% White. The student population is further designated; .4% English Learners, .4% Foster Youth, 2.0% Homeless, Socioeconomically Disadvantaged 39.2%, and Students with Disabilities 12.4%. It is located in Tuolumne County in a rural mountainous, unincorporated area. Most of our students are bused to school from dissimilar housing subdivisions and land parcels. The population has a range of 0-10 Limited English-Speaking students. In spite of the diverse socioeconomic backgrounds from which they come, students interact very positively with one another at school. Our student population blends together with minimal friction based on social, cultural, or economic prejudice. Our mission is to cultivate excellence: by challenging our students, staff, and school community to reach their maximum potential; by using innovative, enlightening curriculum and educational programs with reliable infrastructure; and by providing technology-embedded instruction across content areas. In nurturing excellence, we develop learners who are productive workers, effective communicators, resourceful thinkers, and responsive citizens.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

The annual performance based on a review of the California School Dashboard from school year 2023-2024 and other local data shows that the district is making progress on goals although there are some inconsistencies to growth. In academics, Language arts CAASPP scores school wide remained roughly the same as the prior year at 6.2 points below standard; in Math CAASPP scores school wide increased by 2.0 points. Homeless declined by 42.1 points in Language Arts and are 1.9 points below standard. Homeless also decreased 62.5 points in Math. Chronic absenteeism school wide declined 4.5%. School Connectedness has shown improvement over the last few years, but now has shown a decline to 59 which is below the state average (CHKS). High expectations, meaningful participation, perceived school safety, positive behavior, parent involvement in schooling, and facilities upkeep all reported a falling off under the state average 2025(CHKS). Frequent sadness is still lower than the 37% in 2022 but has now shown an increase to 30% in 2025 (CHKS). Adults at school care about you is up from 56% in 2022 to 66% in 2025(CHKS). Although our Students with Disabilities (SWD) increased 14.8 points in Language Arts, they are still 67.2 points below standard; SWD increased 20.8 points in Math and are still 68.2 points below standard. Our Two or More Races subgroup had a reduction in their suspension rate and a reduction in chronic absenteeism rate of 17.9%, down 22.7% (2024 Dashboard). The district will continue to address academic needs of SWD with paraprofessional and other staff support. Students of Two or More Races will continue to have quarterly attendance reviews by administration.

Based on the 2023 Dashboard, multiple Races/Two or More student groups had all lowest status on all indicators but one. In response to this, the school has made several revisions and updates to its attendance practices. To improve outcomes in this area, each year the school administration will/has continued to conduct quarterly attendance reviews with an emphasis on the outcomes for this specific student groups and other groups who are in jeopardy of being identified as low performing. Goal 1 directly addresses supports for students from the identified groups above. The school will continue to look for new and inventive ways to support these subgroups of students with their attendance, performance of state testing and their overall school connectedness. Soulsbyville does not have any unexpended LREBG funds for the upcoming year.

Educational partners influenced the adopted LCAP by advocating that the measurable metric for the academic goal one to include an overall school wide growth using CAASPP scores for Language Arts and Math as well as individual grade levels: Science scores were also added and will be measured at grades 5 and 8. In addition, educational partners all supported continuing with school counseling, PBIS implementation, and other activities relating to goal two which had been updated/modified from previous LCAP cycle. In regards to addressing the needs of low performing student groups, specifically the Multiple Races/Two or More student group, educational partners noted the need for continued support and outreach of the families of these student groups. Additionally, educational partners from the 24/25 school year encouraged the school district to include paraeducators in trainings related to support students behavior and stressed that counseling services need to remain in place for students.

Goal Analysis [2024-25]

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

The implementation of goal number one; continual improvement in school wide academic achievement for all students as measured by the CAASPP state testing and School Dashboard Indicators is best described as a mix of success and disappointments. By observation and practice the system is being implemented to support our students fully. Using the RTI and PBIS models of support for students is extensive on our campus and being implemented. Students, across the board, have access to approved curriculum at all grade levels. In an analysis of the CAASPP scores there are some inconsistencies. We have made great progress towards our goals in many grade levels. Some grade levels have even exceeded our 2026/2027 goals on outcomes. There are some areas where we have had challenges and not made the intended bench marks year over year. We will need to identify the areas where we are facing these challenges and then focus more attention/support to those areas over the coming year. These specific challenges that we continue to face include regular attendance of students; making them available for learning, continued transient population of students which move from district to district in our region, and continued effects from the Covid outbreak which includes mental health effects.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Material Difference for Action 1.1 between Budget and Estimated Actuals increased \$25,000. Factors contributing include expanded support coverage due to student enrollment shifts and increased demand for classroom assistance. Action 1.2 material difference between Budget and Estimated Actuals decreased \$3,000.00. Factors contributing include some planned professional development sessions were postponed due to scheduling conflicts and staff availability. Additionally, cost savings were realized through virtual rather than in-person formats, which reduced travel and accommodation expenses. Action 1.3 material difference between Budget and Estimated Actuals decreased \$15,000. Factors contributing include fewer devices and accessories were needed than originally anticipated due existing inventory sufficiency. Additionally, some software licenses were renewed at a reduced rate and/or were not up for renewal this year.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

Adding paraprofessional support to our students has been effective. Students feel more supported in the school environment. Additionally, when a student is identified for needing further assistance the RTI staff work with the regular education teacher to pull students for increased targeted instruction to address the student's specific needs. Furthermore, the PBIS system is used to address the behaviors and develop a plan to keep students engaged within the regular education program where the students can receive instruction with their peers and from the certificated teacher.

We have not felt the need to change the overall goal as a result of the CAASPP scores. The modifications will be mostly in the area of continual monitoring of our needs at certain grade levels. We need to be able to identify the areas where we can focus more support or trainings to address the needs. A change in allocated funds under Action 1.3 contribute to fewer devices and accessories needed than

originally anticipated due existing inventory sufficiency. Additionally, some software licenses were renewed at a reduced rate and/or were not up for renewal this year.

Goal Analysis [2024-25]

Overall implementation of goal number two has been steady. The results show that chronic absenteeism has gone down by %, parent involvement has increase by 24%, the suspension rate has continued to drop .3%, and the drop out rate and facilities are holding steady. There are some concerns around students feeling safe and school connectiveness. These areas will all still be a focus over the next year, but we need to highlight safety and connectedness. These areas are being addressed with our increased counselor time and our wellness coordinator. Each of these staff members are critical to the multi tiered system of support for our students. Overall, the goal is showing targeted success on supporting students attendance who have been in our district, but the challenges still remain on identifying the new students who come to our district before they present chronic attendance issues. Furthermore, the need for being proactive and addressing attendance issues early is a continued challenge.

The wellness coordinator and the counselor have been instrumental in coordinating the multi tiered system of support. As a result of the overall development of this system our chronic absenteeism, suspension, and drop out rate are all very low. These results show that our system of support is working and making positive changes to the school. Additionally, the school physical plant is maintained to a good level of evaluation and lends itself to pride for the school. The area where we need more work is in the area of school connectedness and school safety. Students still indicated the need for increased school safety.

 - This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

- **Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)**
 - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**
 - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
