Notice is hereby given that Tuolumne County Board of Education will hold a PUBLIC HEARING at a regular board meeting, February 2, 2026 at 4:00PM, or as soon thereafter as practicable in room 217 of the Tuolumne County Superintendent of Schools Office (175 Fairview Lane, Sonora, Ca) and via Zoom.

The Tuolumne County Superintendent of Schools is applying for Two Extended School Year (ESY) waivers to reduce the instructional days from a total of 20 days to 15 days.

The instructional time for grades TK-12 and Transition will be increased from four (4) hours to five hours, thirty minutes (5.5 hours) for a duration of fifteen instructional days.

The TCSOS Structured preschool ESY program will consist of two daily sessions, each lasting two(2) hours.

The tentatively planned instructional days will be June 10-July 1, 2026 and may adjust according to school year extensions resulting from inclement weather conditions of 25-26 and June 11- July 1 2027 and may adjust according to

school year extensions resulting from inclement weather conditions of 26-27. .
