Involvement Process for the SPSA and Annual Review and Update

Tuolumne County Superintendent of Schools Office engaged educational partners in multiple formats during the Spring of 2022. Stakeholder input was used to develop the LCAP (Local Control Accountability Plan), and this School Plan for Student Achievement. Results of stakeholder input were shared and feedback was received with representatives of TCSOS staff; and during the School Site Council meeting in Spring of 2022. CHKS results were shared with the Tuolumne County Board of Education in November, 2022. Teachers and administrators of TLC and GREC review student academic progress, behavior records and standardized assessments to determine student needs. The School Site Council reviewed and approved this plan on December 20, 2022.

#### Goal 1

Provide training and support for all staff to address the social-emotional needs of students, utilize trauma informed practices, and positive behavior reinforcements.

#### **Identified Need**

The coordinator meets with each student prior to enrollment, and input is received from parents and referring schools. Behavior, discipline and academic records are reviewed by school staff as well as a mental health screening that is conducted by Behavioral Health. Results of these meetings frequently indicate social emotional needs that need to be addressed. In addition, California Healthy Kids Survey results from 2021-22 demonstrate 50% of students in TCSOS non-traditional programs who completed the survey are experiencing chronic sadness and/or feelings of hopelessness. While this is an improvement from the 67% in 2020-21 who indicated they were experiencing feelings of chronic sadness or hopelessness, the results are still very concerning. Multiple studies indicate that incarcerated youth have undergone higher experiences of adverse and trauma related situations, as well as struggles with self-regulation and behavior.

Student behaviors, as measured by teacher observation and positive behavior tickets, improved. CHKS results demonstrated that feelings of chronic sadness and hopelessness are still a major concern. Trauma Informed Practices training was provided by the coordinator.

During the 2021-22 school year, staff were not able to attend PBIS training.

Trauma informed practices were added to the list of training for staff to attend. Because the teacher in GREC has completed Tier I and Tier II of PBIS, "additional training in behavior support" is listed to provide options of the most effective training.

Provide training and materials for all staff to address academic needs of students and improve academic performance; improve progress of students towards graduation.

#### **Identified Need**

A review of student performance on multiple measures indicates students are not meeting academic standards, and nearly 80% of students enrolled at GREC are credit deficient when they enroll.

The administration of Benchmark assessments was more frequent in the 2021-22 school year than in the prior year. The number of students participating in credit recovery opportunities increased between the 2020-21 and 2021-22 school year. The CAASPP results were too limited to receive score reports.

      - iii. implementation of a schoolwide tiered model to prevent and address problem behavior:
      - iv. professional development and other activities for teachers, paraprofessionals, and other school personnel to improve instruction and use of data; and
      - v. strategies for assisting preschool children in the transition from early childhood education programs to local elementary school programs.
- C.   - 1. Ensure that those students' difficulties are identified on a timely basis; and
  - 2. Provide sufficient information on which to base effective assistance to those students.

- 1. Be informed by all state indicators, including student performance against state-determined long-term goals (Goal, Identified Need, Expected Annual Measurable Outcomes, Annual Review and Update, as applicable); and
- 2. Include evidence-based interventions (Planned Strategies/Activities, Annual Review and Update, as applicable). # Single School Districts and Charter Schools Identified for School Improvement

Single school districts (SSDs) or charter schools that are identified for CSI, TSI, or ATSI, shall develop a SPSA that addresses the applicable requirements above as a condition of receiving funds (EC Section 64001[a] as amended by Assembly Bill [AB] 716, effective January 1, 2019).

However, a SSD or a charter school may streamline the process by combining state and federal requirements into one document which may include the local control and accountability plan (LCAP) and all federal planning requirements, provided that the combined plan is able to demonstrate that the legal requirements for each of the plans is met (EC Section 52062[a] as amended by AB 716, effective January 1, 2019).

Planning requirements for single school districts and charter schools choosing to exercise this option are available in the LCAP Instructions.
