Involvement Process for the SPSA and Annual Review and Update

Tuolumne County Superintendent of Schools Office engaged stakeholders in multiple formats during the Spring of 2022. Stakeholder input was used to develop the LCAP (Local Control Accountability Plan), and this School Plan for Student Achievement. Results of stakeholder input were shared and feedback was received with representatives of TCSOS staff; with the Governing Board, and during the School Site Council meetings in spring and fall, 2022. Teachers and administrators of TLC and GREC review student academic progress, behavior records and standardized assessments to determine student needs. The School Site Council reviewed and approved this plan on December 20, 2022.

Goal 1

Provide training and supports for all staff to address the social-emotional needs of students and in positive behavior reinforcements, and to provide social-emotional support to all students.

Identified Need

The coordinator and counselor meet with each student prior to enrollment, and input is received from parents and referring schools. Behavior, discipline and academic records are reviewed by school staff. Results of these meetings frequently indicate social emotional needs that need to be addressed. Multiple studies indicate that many expelled and at-risk youth have undergone higher experiences of adverse and trauma related situations, as well as demonstrating struggles with self-regulation and behavior. In 2018-19, the rate for suspensions in TLC was 12.8%. In 2019-20, the rate decreased significantly to 2.5%. In 2020-21, the rate was 7.1%. In 2021-22, the rate was: 0.0%

The number of student contacts by the counselor increased significantly from 19-20 (224) to 2020-21(330). In 2021-22, the number of student contacts by the counselor increased to 589. The suspension rate decreased, from 12.8% in 18-19 to 2.5% in 19-20 and increased to 7.1% in 20-21, but decreased to 0.0% in 2021-22.

PBIS trainings were not attended in 2021-22 due to lack of substitute coverage.

Goal 2

Provide training and materials for all staff to address academic needs of students and improve academic performance. Due to the small number of students enrolled in TLC student group reports are not always available for standardized test results or Dashboard indicators. However, staff review of standardized testing results and classroom assessments for each student indicate that a high percentage of students are not performing at grade level.

Identified Need

Review of student performance on multiple measures indicates that the majority of students are not performing at grade level. In the 2021-22 school year, approximately 60% of students that enrolled in TLC High School were credit deficient.

- F. A description of the activities the school will include to ensure that students who experience difficulty attaining proficient or advanced levels of academic achievement standards will be provided with effective, timely additional support, including measures to
 - 1. Ensure that those students' difficulties are identified on a timely basis; and
 - 2. Provide sufficient information on which to base effective assistance to those students.
- G. For an elementary school, a description of how the school will assist preschool students in the successful transition from early childhood programs to the school.
- H. A description of how the school will use resources to carry out these components (described in the Proposed Expenditures for Strategies/Activities).
- I. A description of any other activities and objectives as established by the SSC (described in the Strategies/Activities).

The TSI plan shall:

- 1. Be informed by all state indicators, including student performance against state-determined long-term goals (Goal, Identified Need, Expected Annual Measurable Outcomes, Annual Review and Update, as applicable); and
- 2. Include evidence-based interventions (Planned Strategies/Activities, Annual Review and Update, as applicable). (For resources related to evidence-based interventions, see the U.S. Department of Education's "Using Evidence to Strengthen Education Investments" https://www2.ed.gov/policy/elsec/leg/essa/guidanceuseseinvestment.pdf.)

Additional Targeted Support and Improvement

A school identified for ATSI shall:

 Identify resource inequities, which may include a review of LEA- and school-level budgeting, which will be addressed through implementation of its TSI plan (Goal, Identified Need, Expected Annual Measurable Outcomes, Planned Strategies/Activities, and Annual Review and Update, as applicable).

Single School Districts and Charter Schools Identified for School Improvement

Single school districts (SSDs) or charter schools that are identified for CSI, TSI, or ATSI, shall develop a SPSA that addresses the applicable requirements above as a condition of receiving funds (EC Section 64001[a] as amended by Assembly Bill [AB] 716, effective January 1, 2019).

However, a SSD or a charter school may streamline the process by combining state and federal requirements into one document which may include the local control and accountability plan (LCAP) and all federal planning requirements, provided that the combined plan is able to demonstrate that the legal requirements for each of the plans is met (EC Section 52062[a] as amended by AB 716, effective January 1, 2019).

Planning requirements for single school districts and charter schools choosing to exercise this option are available in the LCAP Instructions.
